This year's event features a seated dinner, basket raffle, and a nice evening to be had by all!

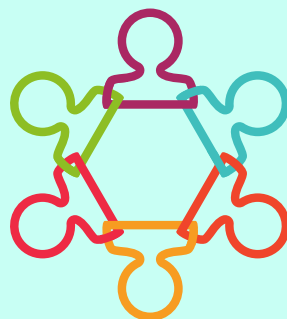
Our Mission Statement

September, October and November are busy months at the DV Coalition!

In September, Courtney Winkler, DCADV's Training Coordinator and the training team will be presenting DV101, a two-day conference on the dynamics of DV. The DV101 training is an opportunity for new advocates, therapists, first responders, medical personnel and social workers to learn more about intimate partner violence, including trauma-informed responses and available statewide resources. During the training the participants have an opportunity to meet face-to-face with domestic violence service providers from across the state to learn more about programs and supports. This component of the training brings "faces to the work" and encourages networking and community connections.

In October, DCADV will be celebrating the organization's 25th anniversary! This year's Purple Ribbon Event (PRE) will be held on October 3rd and it will be an acknowledgement of the agency's history and ongoing commitment to end and prevent domestic violence. We will be recognizing DCADV's founding Executive Director Carol Post. Carol retired just a few years ago, but her legacy lives on. We are thrilled to come together: supporting members, community partners, advocates and friends – to celebrate Carol, the anniversary and our shared commitment.

Policy Update

The DCADV Policy Team regularly participated in advocacy this past spring and was able to share information on what victims' need and want, about evidence based best practices and lessons learned, and also to raise awareness on the current limitations of Delaware's domestic violence response systems. The 150th General Assembly's welcomed 17 new members which gave DCADV the opportunity to educate our elected officials and talk with them about the many issues survivors and their families face. In addition, the session saw a very active legislative agenda including equal rights and privacy rights, criminal justice reform, and prevention.

Along with member programs, DCADV advocated with the Governor's Office and key members of the General Assembly to secure funding increases in the 2019-20 state budget and Grant in Aid bill. We were excited to receive these increases which will allow service programs to address gaps created by years of state funding cuts. The reality though is that many of our programs remain underfunded leaving survivors in search of needed support either financially, with safe and affordable housing, or legal advocacy beyond the crisis. Securing adequate funding remains a priority for the coming year.

The Coalition also weighed in on efforts to reform Delaware's justice system. Our Coalition believes in the importance of addressing the negative impact that crime and the justice system have on people living in poverty and people of color, but we are equally committed to raising victims' voices for the need for safety and offender accountability. We continue to work with leaders and community partners to identify policies where change can occur without jeopardizing victim and community safety.

A top policy priority of the Coalition is establishing victim confidentiality and advocate privilege within Delaware law. Although federal statutes require advocates to maintain victim confidentiality, Delaware's code is silent which creates a loophole regarding privacy rights. HB 215 seeks to close that loophole and provides victims of domestic violence, sexual violence, caregiver abuse, human trafficking, or stalking with a clear right to confidentiality and creates a legal protection regarding their communications with community based or college campus victim advocates. We anticipate this bill being worked early next year.
