EXECUTIVE DIRECTOR'S STATEMENT

Dear Friends and Advocates:

This past fiscal year has been a dynamic year! A year of celebration and challenge! Throughout the year we remained grateful to our member agencies and supporters for their partnership in our shared commitment to end and prevent domestic violence.

DCADV celebrated its 30th anniversary during this past year's Purple Ribbon Event! It was a wonderful evening in which we honored DCADV's founding ED, Carol Post, and the work of our member agencies and community partners! The Women of Color Task Force (WOCTF) also celebrated their 25th Anniversary. DCADV is so grateful to the WOCTF for their partnership!

The Board developed a new strategic plan, which incorporates the Coalition's goals to advocate for victim safety, promote prevention strategies, and collaborate with diverse community partners to enhance community resources. DCADV's Board is actively engaged in the Coalition's efforts to be a responsive resource to member agencies and DV service providers.

DCADV continues to be an important training resource for DV Advocates and community agencies. This past year, DCADV developed several online training modules, including Foundations of Domestic Violence, Foundations of Trauma-informed Care, and Foundations of Prevention. DCADV also developed a DV201 training series to delve deeper into topics such as Custody & Visitation and a four-part training series on the intersection of Intimate Partner Violence and Social Determinants of Health.

DCADV continued to advocate for victim safety, working in collaboration with member agencies and system partners to ensure that state policies and laws are responsive to the needs of DV survivors. DCADV also continued to advocate for more state funding for DV service providers. In addition, the Coalition collaborated with the Community Health Worker (CHW) Association on efforts to create a certification pathway and to support efforts for Medicaid reimbursement.

During this past year, DCADV welcomed some new staff members including our new Director of Advocacy & Policy, Deianna Tyree McDuffy, and our new Economic Justice Policy & Prevention Coordinator, Rajan Parikh. We also promoted Ama Amponsah to Program Manager of the DV-Community Health Project.

On the business side of things, we migrated our server to the Cloud. If you have ever been involved in this type of project, you can appreciate the enormity of the work. We are grateful to our administrative staff and tech support!

DCADV is deeply appreciative of the courageous women within the Women Empowered Against Violence in Every Relationship (WEAVER) task force and the Women of Color task force (WOCTF).

Thank you to all the individual donors, organizations, and funders for their generosity and support! Thank you for your shared commitment to end and prevent domestic violence.

Celebrating Our Twenty-Fifth Anniversary of Service




The **Women of Color Task Force (WOCTF)** works to increase public awareness of domestic violence and available resources – especially in communities of color – through education/training, advocacy, and support. In FY25, the WOCTF continued its monthly hybrid meetings, celebrated its 25th anniversary with a conference which included Pieces of a Dream Dance Troupe, Coalition for a Safer DE, Miss Delaware, and a play (To the Moon) reading by members, and increased its affiliations with local SW universities by joining DSU and UD advisory boards. The task force provided outreach to at least 1,728 members of the local community.



ADVOCACY & POLICY

We support policies, programs, and laws that align with DCADV's mission and goals of ending domestic violence. We believe that violence can and should be prevented. We work with survivors and community partners to better understand what is needed most to help victims of abuse find safety, healing, and justice. We continue to prioritize funding and support for our members and community service partners as victims' calls for assistance remain high!

Fall 2024

- Advocated for victim's safety and offender accountability through the Probation Reform Bills with the DVTF Joint Legislative Task Force.
- Provided TA to local, aspiring service provider interested in opening a Family Visitation Center (FVC) and to existing FVC leadership.
- Provided trainings on federal housing protections at the PennDel AHMA Conference and a housing and economic justice training with the Sussex Housing Group for Domestic Violence Awareness Month.
- Met with policy stakeholders to prepare for the 2025 Legislative Session.

Winter 2024/2025

- Attended the Spotlight Delaware Legislative Summit to discuss policy issues.
- Collaborated with the DV Task Force legislative committee to advocate for the Victims' Bill of Rights and Probation Reform bills.

Spring 2025

- Assisted with Crime Victims' Rights Week Advocacy Day in collaboration with the DV Task Force and Victims' Rights Task Force.
- Partnered with the Community Health Worker Association, member programs, and legislators to support efforts to advance a Medicaid plan for community health workers.
- Participated in the Women's Legislative Caucus to highlight the group's achievements.
- Advocated for Grant-in-Aid and DV service provider funding.

Summer 2025

- Attended NNEDV's Annual Advocacy Days with a member of the WEAVER Task Force.
- Attended the National Training Institute's NCVC Annual Conference to learn more about best practice for victims' service providers across the country.

DV & HEALTH

The DV-Community Health Worker (DV-CHW) Project continues to make a meaningful impact across Delaware, serving 133 new survivors and 225 of their children, with an average monthly caseload of 50 participants. The program remains strong statewide, and survivors consistently report fewer poor health days while engaged with their DV-CHW. The DV-Community Health Advocates at CHILD, Inc. and People's Place work diligently to ensure participants have improved access to community resources, feel healthier, safer, and are better equipped to plan for the future. We are deeply grateful for their dedication and hard work throughout all the challenges they have faced.



"My advocate has been extremely helpful, always there when I need help and she goes above and beyond to make sure me and my children are doing good"



"The level of patience and support. The ability to have an advocate who understands the struggle. The most helpful for me has been shelter, employment, and transportation."

PREVENTION

DELTA: AHEAD - Year 3

Domestic Violence Prevention Enhancement and Leadership Through Alliances: Achieving Health Equity through Addressing Disparities

DCADV continues to have the privilege of being funded through the Centers for Disease Control and Prevention (CDC) for almost two decades to advance efforts in intimate partner violence prevention! As **DELTA: AHEAD** moved into Year 3, DCADV and our partners at CHILD, Inc. and People's Place made a lot of exciting progress in advancing health equity. The focus of this five-year grant is to expand the services and offerings on a community and statewide level, addressing health equity in order to create safer and healthier communities.



CHILD, Inc.'s Sparrow Run Family Resource Center (FRC)

continued to provide vital resources, support, and education individuals and families in their community. This year, the FRC continued to expand services to residents along the Route 40 Corridor. They also expanded their Community Garden Project, offering more raised beds to the residents of Sparrow run, helping to increase community connectedness.

People's Place continued its work engaging schools and other youth serving spaces in providing *REAL Relationships* workshops and other resources to help keep young people safe. This year, their partnerships grew stronger with groups like DAPI led to increased support for young people. These strong partnerships are opening doors to Middle Schools, a new avenue for their work.



INVEST|DE

Integrating Non-Violent Economic Strategies Throughout Delaware (INVEST DE) is a DELTA-funded workgroup that facilitates cross-sector collaboration on ways to increase awareness and adoption of economically-just workplace policies.

Guided by our [white paper](#), *Economic Justice as a Framework for Violence Prevention*, INVEST-DE continued targeted outreach to increase membership and increase awareness of data-informed economically just workplace policies. INVEST members also joined a panel discussion at our Annual Advocate's Conference and Networking Event called *Financial Empowerment: Mapping Out a Safer Future*.

INVEST DE has expanded partnerships to grow the pool of Economically Just Training providers and is building a statewide network of Trauma-Informed Financial Literacy and Empowerment Educators. The group has drafted fact sheets that translate White Paper recommendations into practical guidance. INVEST DE also developed a strategic plan to engage Delaware employers around economically just practices and began direct outreach to businesses to introduce resources and invite collaboration.
