This **30th anniversary year** has been a busy one in which the Coalition engaged in advocacy, training, and primary prevention. Throughout the year, we worked in collaboration with our member programs and community partners.

30 Years...

DCADV was founded in April 1994, and we acknowledged this 30-year anniversary throughout the year! The Coalition continues the work that began 30 years ago, passionately advocating with DV survivors for policies and laws that enhance safety. DCADV is truly grateful and inspired by the courageous women within the Women Empowered Against Violence in Every Relationship (WEAVER) Task Force and by the leadership and commitment of the Women of Color Task Force (WOCTF)!

The **Women of Color Task Force celebrated their 25-year anniversary in 2024**! These dedicated women continue to raise awareness about domestic violence through outreach events, community education and their work with the faith community. We are honored to work in partnership with Carolyn Morgan, the Chair of the WOCTF, and all the task force members!

Advocacy....

DCADV continues to engage in advocacy to increase funding for DV services. In addition, our advocacy addressed legislative and policy efforts on criminal justice, health equity, housing and prevention. We joined community partners to review the Victims' Bill of Rights and provided input for enhancing these rights. DCADV worked with Family Court, the DV Coordinating Council and community partners on planning and advocacy efforts to create a statewide Family Justice Center.

Training...

DCADV offers training for DV advocates and community partners throughout the year, including DV101 (offered in the Fall and Spring), the Advocates' Retreat & Conference, Family Court, and mental health providers. DCADV continues to add to its online training modules, offering flexibility and ease in receiving empowering information.

Primary Prevention...

DCADV continued to partner with member programs on primary prevention strategies that address economic security and teen healthy relationships, which are strategies that address the risk factors of intimate partner violence. DCADV continues to promote economic justice through INVEST DE and share best practices and workplace policies that can enhance health and economic security.

All the work that we do as a Coalition is possible because of the dedication and commitment of the Staff, the Board, our Member Programs and you! We truly appreciate the individual members and donors, organizations and funders for your generosity and support!

Our Mission Statement

The Delaware Coalition Against Domestic Violence is a statewide, nonprofit organization and coalition of organizations, groups and individuals that strive to promote conditions that prevent and eliminate domestic violence by educating its members and community partners; providing informational resources to the community; and advocating as a strong, unified voice for victims/survivors of domestic violence, children who are affected, domestic violence programs and victim service providers.

Our Member Agencies



Member Organizations provide direct services to adult and child victims of domestic violence through hotlines, community advocacy, shelters, visitation centers, legal services, therapeutic programs, as well as offering treatment programs for offenders. They support the mission, goals, and philosophy of DCADV and work with DCADV to create an environment in which those victimized by domestic violence become empowered. Representatives from our member organizations serve on our Board of Directors.

Task Forces

The **WEAVER Task Force**, established by the Delaware Coalition Against Domestic Violence (DCADV), consists of survivors of intimate partner violence (IPV) who are committed to educating the community and advocating for systemic change. Their mission centers on sharing their personal experiences to highlight the importance of support services for survivors and to engage the community in conversations about domestic violence.

The **Women of Color Task Force** (WOCTF) works to increase public awareness of domestic violence and available resources – especially in communities of color – through education/training, advocacy and support. In FY24, the WOCTF continued its monthly hybrid meetings, updated its print outreach materials, strengthened its relationship with DESU (DE's only HBCU), conducted its first Zoom webinar ("Financial Wisdom for DV Survivors... & You") and provided outreach to at least 1,841 members of the local community (an increase of 26%). And, one of its longterm members, Paulette Sullivan-Moore, was inducted into the DE Womens Hall of Fame.




PRIORITIZING RACIAL EQUITY

DCADV understands that engaging in the work of racial equity is essential in our efforts to end and prevent domestic violence. DCADV understands that the work of racial equity is intersectional and necessarily includes preventing and intervening in gender-based violence.

Throughout 2024, DCADV continued to implement our Racial Equity Plan. The Coalition held a joint Board-Staff meeting to review our progress on implementing the plan to ensure it remains a dynamic and empowering process. This work has included updating the HR policies using a racial equity and inclusion lens. One of the policies that was added is the Lactation Policy, which helps to support chest/breastfeeding parents and their continued participation in the workforce. This policy is part of a supportive economic justice framework that empowers staff, promotes health and provides a supportive, inclusive work environment.








Throughout the year, staff engaged in dialogue about racial equity. These monthly conversations often centered around articles, books, podcasts, and webinars that we experienced together. Topics have included implicit bias, poverty, politics, and the prison system. We've learned from the community around us through field trips to historic New Castle and to the Delaware Art Museum's "There Is a Woman in Every Color: Black Women in Art" exhibit. We've also been fortunate to learn from a local expert about the history of Delaware State University. This year, with the guidance from the National Indigenous Women's Resource Center (NIWRC) and the Chief of the Nanticoke Indian Tribe, we drafted a Land Acknowledgement statement. DCADV engages in this land acknowledgement to note both the historical and current strength of the Lenape and Nanticoke People, to advance equity, and to highlight the importance of working in collaboration with our Tribal partners to end and prevent domestic violence. DCADV recognizes the importance of connecting with community-based and culturally specific organizations to learn about the needs of the most marginalized communities and to address these needs collaboratively. 



We support policies, programs, and laws that align with DCADV's mission and goals of ending domestic violence. We believe that violence can and should be prevented. We work with survivors and community partners to better understand what is needed most to help victims of abuse find safety, healing, and justice. We continue to prioritize funding and support for our members and community service partners as calls for assistance remain high!

PREVENTION

DELTA AHEAD - Year 2

DCADV continues to have the privilege of being funded through the Centers for Disease Control and Prevention (CDC) for almost two decades to advance efforts in intimate partner violence prevention! As **DELTA AHEAD** (Domestic Violence Prevention Enhancement and Leadership Through Alliances: Achieving Health Equity through Addressing Disparities) moved into Year 2, DCADV and our partners at CHILD, Inc. and People's Place made a lot of exciting progress in advancing health equity.



CHILD, Inc.'s Sparrow Run Family Resource Center continued to provide vital resources, support, and education individuals and families in their community. They have also made important strides in expanding their reach beyond Sparrow Run into the surrounding communities along the Route 40 Corridor.

People's Place continued its work engaging schools, school health centers, and other youth serving spaces in providing *REAL Relationships* workshops and other resources to help keep young people safe. They took important strides in engaging community-based health centers, as well as new partners beyond schools.



In January 2024, DCADV completed the **Rape Prevention Education** (RPE) Grant project with The Division of Public Health, DCADV's RPF project has a strong focus on economic justice, which will continue through our efforts under DELTA AHEAD and other initiatives. DCADV is proud to continue to support our friends at DPH and the Delaware Alliance Against Sexual Assault (DAASV) as they carry this important work forward!

INVEST DE

Integrating Non-Violent Economic Strategies Throughout Delaware (INVEST DE) is a DELTA-funded workgroup that facilitates cross-sector collaboration on ways to increase awareness and adoption of economicallyjust workplace policies.

INVEST DE has engaged in a targeted outreach effort to gain new members and increase availability of data-informed policies from our <u>white paper</u>, *Economic Justice as a Framework for Violence Prevention*.

INVEST DE has been expanding its community partnerships to build a roster of Economically Just Training providers. INVEST also is working to build a network of Trauma- Informed Financial Literacy and Empowerment Educators to help increase the quality of this education around the state.

INVEST DE works together to make economic justice a reality for all Delawareans.
