### **Prevention & Economic Justice Update**



DCADV in collaboration with The Biden Institute and University of Delaware's Center for the Study of Prevention and Gender Based Violence hosted a 3 part webinar series titled, "Economic Justice through Social Responsibility". The 3 part series took place across the month of October and highlighted local and national speakers that were able to speak to the intersection of financial stability and gender based violence, specifically domestic and sexual violence. This project was funded by the Rape Prevention Education grant, Rape Prevention and Education: Using the Best Available Evidence for Sexual Violence Prevention.

DCADV's RPE program will continue efforts to provide education and training around economic stability and prevention policy initiatives.


### **Training & Outreach Update**

### **Housing Update**

Improving survivors' access to safe, stable, and affordable housing has continued to be a significant priority and focus of our work. Towards this, DCADV went live recently with a newly created housing section on our website. We are proud to be able to host the extensive work of the Domestic Violence Task Force's Housing Subcommittee's efforts to create clear and consistent resource materials for survivors and their advocates to access. There is specific information about Delaware's housing resources, details about housing rights and protections available, as well as national guidance about best practices. ## Nanticoke Project Update

Significant progress has been made with the Nanticoke Resource Guides for Safe & Healthy Relationships Project, a collaborative partnership of the Nanticoke Indian Association and the Delaware Coalition Against Domestic Violence (DCADV). The Resource Guide Project is designed to identify, train, and support tribal members who can serve as a resource for anyone in the Nanticoke community who may be a victim of domestic violence or may need access to community resources to support healthy relationships. To date, ten tribal members are actively engaged in learning and community organizing through virtual sessions with staff from the Delaware Coalition Against Domestic Violence



The Nanticoke Resources Guides extensive training is being offered via zoom due to the safety precautions needed with the pandemic. Despite the challenges that Covid presents, this group has been active and committed to the project. Training topics have included healthy relationships, understanding dynamics of abuse, how to empower and support survivors, as well as how to access safety and extensive community services. Guest from community agencies have joined the zoom sessions to share information with the Resource Guides. Resource Guides are paid a stipend through a State of Delaware grant that recognizes the value of their time and efforts.

In the coming months, the Resource Guides will learn more about community resources, including how to access local substance abuse treatment. They will also be developing resource materials that are specific for the Nanticoke community. Efforts are underway to assure that the project continues beyond the initial training, including developing a way to add new participants, assure resource information is up to date, and to connect with national indigenous organizations that are doing similar work.
